

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next eleven years to 0 tCO₂e by 2035. This is a reduction of 10% year on year (approx.)

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 6,219 tCO₂e, a 31% reduction against the 2021 baseline and the measures will be in effect when performing the contract

Hybrid car company cars have been introduced and solar panels have been installed on office roof. The benefit of solar panels has not yet been calculated in our workings.

In the future we hope to investigate the viability of further measures such as:

- Moving to a renewable energy supplier
- Update lighting to low energy bulbs
- Mains gas as a source of heating vs heat pumps
- Relocation to a more energy efficient building
